Directions:

From the Show Site – From Lions Gate Hotel: - Turn right onto Watt Ave. take I-80 Business Route West entrance (not the San Francisco I-80 entrance, but the Business route, 2nd entrance off of Watt) approx. 3.9 miles, till it connects/merges with CA-99 South. Continue on CA-99 South, approx. 10 miles and take Florin Rd. East exit. Go approx. one and ½ miles and turn right onto Palmer House Dr. Continue on Palmer House for less than ½ mile. James Rutter Middle School is on the right, and turn right into school parking lot next to field .

From the Sacramento area: Take CA-99 South. Continue on CA-99 South, approx. 10 miles and take Florin Rd. East exit. Go approx. one and ½ miles and turn right onto Palmer House Dr. Continue on Palmer House for less than ½ mile. James Rutter Middle School is on the right, and turn right into school parking lot next to field .

From the San Francisco area: Take I-80 East to Sacramento. Do **NOT** take the I-80 north Tahoe turnoff, continue on Business I-80 thru Sacramento and turn **right** onto CA-99 South. Continue on CA-99 South, approx. 5 miles and take the Florin Rd. East exit. Go approx. one and ½ miles and turn right onto Palmer House Dr. Continue on Palmer House for less than ½ mile. James Rutter Middle School is on the right (7350 Palmer House Dr), and turn right into school parking lot next to field.

ELIGIBLE BREEDS/REGISTRY:

Only purebred Italian Greyhounds. Spayed and neutered hounds are eligible to compete; Monorchid or Cryptorchid are not eligible. All entries shall be individually registered with AKC, have ILP# or is registered with AKC-recognized foreign registry. Substitutions are allowed for lame or in-season hounds only if the substitute has the same owner and notification is given at least ½ hour before Check In.

STAKES OFFERED:

OPEN: Open Open to all hounds of a breed that have obtained at least one of the following. AKC QC.Courser title, American Kennel Club Field Champions of Record of the breed may be entered. Hounds that are disqualified (or dismissed twice within six trials) from Field Trials may not be entered.

SPECIAL: Open to any hound of an eligible breed who has earned an AKC Field Championship. No championship points in this stake.

VETERAN: Open to all hounds that are eligible to enter the Open or Special stakes and meet the age requirement for a veteran as established by the breed's parent club.

TEST OFFERED:

Junior Courser: Open to all eligible hounds. A hound running alone shall receive a certification from a judge on one date and a second certification from a different judge on a later date, indicating that the hound completed a 600- yard course with a minimum of four turns. The hound must complete the course with enthusiasm and without interruption.

TEST OFFERED: QC:

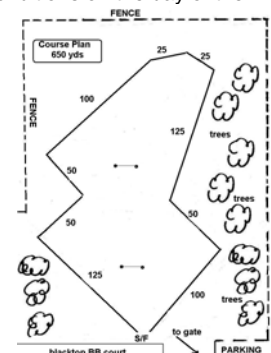
If entering the QC test, you need to supply the qualifying dog in addition to your entry.

If your dog has their JC, but has not yet run in a trial, the QC test is now required prior to entering the first trial.
