Important Information:

Eligibility to enter

FTE (first time entered) racers are eligible to enter if they have already been certified by a qualified race secretary. Qualification run must include running muzzled with another dog, preferably from a starting box. Statement of certification must accompany entry. Racers that do not have a LGRA number must provide a photocopy of the hound's AKC or ILP papers and an additional \$2.00 for Registration along with the entry fee.

All Italian Greyhounds one year of age and older are eligible to participate.

There will be a limited supply of extra muzzles and race blankets available for practices and the race meet. Please bring your own if you have them.

Directions:

From the Show Site – From Lions Gate Hotel: - Turn right onto Watt Ave. take I-80 Business Route West entrance (not the San Francisco I-80 entrance, but the Business route, 2nd entrance off of Watt) approx. 3.9 miles, till it connects/merges with CA-99 South. Continue on CA-99 South, approx. 10 miles and take Florin Rd. East exit. Go approx. one and ½ miles and turn right onto Palmer House Dr. Continue on Palmer House for less than ½ mile. James Rutter Middle School is on the right, and turn right into school parking lot next to field.

From the Sacramento area: Take CA-99 South. Continue on CA-99 South, approx. 10 miles and take Florin Rd. East exit. Go approx. one and ½ miles and turn right onto Palmer House Dr. Continue on Palmer House

for less than 1/2 mile. James Rutter Middle School is on the right, and turn right into school parking lot next to field .

From the San Francisco area: Take I-80 East to Sacramento. Do NOT take the I-80 north Tahoe turnoff, continue on Business I-80 thru Sacramento and turn right onto CA-99 South. Continue on CA-99 South, approx. 5 miles and take the Florin Rd. East exit. Go approx. one and 1/2 miles and turn right onto Palmer House Dr. Continue on Palmer House for less than 1/2 mile. James Rutter Middle School is on the right (7350 Palmer House Dr), and turn right into school parking lot next to field.
