Important Information:

Eligibility to enter

All Italian Greyhounds one year of age and older, who already have NOTRA numbers are eligible to participate.

NOTE: There will not be FTE Entries accepted.

There will be a limited supply of extra muzzles and race blankets available for practices and the race meet. Please bring your own if you have them.

Directions:

From the Show Site – From Lions Gate Hotel: - Turn right onto Watt Ave. take I-80 Business Route West entrance (not the San Francisco I-80 entrance, but the Business route, 2nd entrance off of Watt) approx. 3.9 miles, till it connects/merges with CA-99 South. Continue on CA-99 South, approx. 14 miles and take MACK Rd. West exit. Go 1/2 block and turn left on Valley Hi Drive. Follow this about a mile and a half as it bears right, go past Center Parkway and turn right at Kentwal Dr. The field/school parking lot is on your right.
From the Sacramento area: Take CA-99 South. Continue on CA-99 South, approx. 6 miles and take MACK Rd. West exit. Go 1/2 block and turn left on Valley Hi Drive. Follow this about a mile and a half as it bears right, go past Center Parkway and turn right at Kentwal Dr. The field/school parking lot is on your right.

From the San Francisco area: Take I-80 East to Sacramento. Stay left and Do NOT take the I-80 north Tahoe turnoff, continue on Business I-80 thru Sacramento and exit right onto CA-99 South. Continue on CA-99 South, approx. 6 miles and take the MACK Rd. West exit. Go 1/2 block and turn left on Valley Hi Drive. Follow this about a mile and a half as it bears right, go past Center Parkway and turn right at Kentwal Dr. The field/school parking lot is on your right.
